

IMMUNIZATION REGISTRIES BY STATE

Immunization Information Systems (IIS) are databases that store vaccination records. IISs are designed to provide healthcare providers, public health officials, and patients with accurate and up-to-date information on immunization status.

Listed are the websites and/or contact information for each state's IIS. Some allow the public to access their own records online, while others release documentation after a request has been submitted.

Locate any state(s) you have been vaccinated in to see how you can access your immunization records.

Immunization Registry Tips:

Because vaccines must be entered manually, IISs may not always have a complete record of all immunizations received. Contact your healthcare provider for the most up-to-date records.

Older records (immunizations given in the mid-1990s or earlier) may not be documented in the registry.

If your records are not already in the ISS, you can provide a copy of them to your healthcare provider or local health department so that they can be included. This will make them easier to find in the future.

If you do not want your information stored in the registry, contact your health department to request to have them removed.
